


## UNDERTAKING FOR HOSTEL FACILITY BY THE STUDENT

I, \_\_\_\_\_ S/o/ D/o \_\_\_\_\_ do hereby solemnly affirm and undertake that:

1. I shall abide by all the provisions of the College and Govt. Act, Statutes, Ordinances, Regulations, Rules, Orders, Instructions, Information, Guidelines, Manuals, Code, Circulars etc. in force and as amended from time to time (hereinafter jointly referred to as "the Provisions") of and/or framed by the Government, Institutions, sponsoring Trust and their Institutes, Departments, Divisions, Centers, other constituent units, establishments and facilities including hostels, transportation etc. and concerned authorities, officers, assigns and employees. The Principal /Administrative Officer will be at liberty to impose any penalty or any disciplinary action(s) on me being found guilty of, any sort of misconduct or indiscipline or disobedience or malpractice within or outside the precincts of the Institution, or any act which is detrimental to the interest of the Institution. Principal/ Administrative Officer, in such case, may discontinue my stay in the Institution and I shall not be entitled for any refund of admission fee, hostel fee, bus fee and any other fee / charges paid to the Institution and I shall also be liable to pay the pending fee, dues, penalty, etc.
2. I shall retain the hostel accommodation for the full academic session (i.e. one year) and if due to any reason I leave the hostel during the academic session (one year), I shall pay the hostel charges for the full academic year.
3. I shall not be entitled to claim my admission to the hostel as a matter of right.
4. *I am aware that ragging is a criminal offence and is strictly prohibited. I shall not indulge directly or indirectly in any act of ragging on the campus, in hostels or outside the campus of the Institution. If I am found guilty of indulging into a despicable act of ragging intentionally or unintentionally, the Collegemay take appropriate disciplinary action (including rustication/expulsion from the hostel and/or the Institution) against me and further legal action as per law of land.*
5. I shall not possess, use or deal with any kind of intoxicating material including alcohol, drugs of any kind, gutka, tobacco, cigarettes, chewing gums or any other sedative materials, vulgar/offensive/porn/gory audio-visual, graphic/pictorial content or literature viz. vulgar songs/videos pictures/books jokes and or *contraband goods/items* as determined the Government of India and on being found guilty, the Institution may take any disciplinary action(s), including rustication/expulsion, against me including a legal action as deemed fit.
6. I shall not use abusive/vulgar language and/or indulge in any such physical actions (individually or in a group) that may consist of minor or serious misconduct intentionally or unintentionally and may be found inappropriate/immoral/banned in accordance to the norms of acceptable socio-cultural behaviorand which may be categorized as a Punishable Offence/Juvenile Crime under the Indian Penal Code and on being found guilty, the Institution may take any disciplinary action(s), including rustication/expulsion, against me including a legal action as deemed fit. In case, I find an instance of the same I will inform the concerned authorities immediately.
7. I shall not possess, use or abet the use of any kind of weapons including sticks, rods, explosives, firework or any such material and on being found guilty, the Institution may take any disciplinary action(s), including rustication/expulsion, against me including a legal action as deemed fit.
8. I shall be liable to pay for any damage caused by me to the property of the Institution either alone or jointly with others and face disciplinary action.
9. I do not have the tendency, and shall not make any attempt, to commit suicide or abetting or inciting any other person to commit suicide or anything unwarranted and /or prohibited by law or otherwise and shall not give any sort of threats to commit suicide or likewise and or being found guilty of the aforesaid action, I myself shall be responsible for any consequences under law and the expulsion/rustication from the Institution and any other legal action under the law of land. The College shall not be responsible for the same.
10. I shall not profess/preach/practice and/or uphold any orthodox views of faith/worship and shall never use the hostel/College premises for any such kind of activities.
11. I am medically fit and have no communicable and serious diseases like that of fits, any sort of attacks or any other I shall pay for any expenditure incurred by the Institution on my treatment for any sickness or personal injury due to any reason during the course of my study at the Institution.
12. I shall be liable for full payment of monthly mess charge irrespective of day present. Only declare holiday will be count for adjustment.
13. I shall myself take precautions against insect-bites, dog-bites, snake-bites, animal-bites, plant-bites and maintain hygiene and proper care to ensure safety from any infectious/contagious diseases and shall carry the first -aid kits every time and the College/Hostel Authorities or Administrative Personnel shall not be liable for such infections and diseases.

**ANNEXURE I**  
**Specific Rules for Student Discipline**


1. Students are expected to use only courteous & polite language and behave with decorum, with the faculty members and the staff of the College/Institute.
2. Students shall avoid using any insulting, inciting, threatening language when talking with fellow students and should abstain themselves from violence.
3. Students shall not talk or act in any manner outside the institution in a way that would bring disrepute to the College/Institute.
4. The students shall be regular and punctual in attending classes and all activities connected with the College/Institute. As per university/Board/Council rules 75% attendance is mandatory to appear in final examinations. However for Internship (as applicable) required attendance (as per norms of Council/University/Board) is compulsory.
5. Gathering in groups at roads, entrance, exit and pathways is strictly prohibited.
6. The students shall observe strict silence in the class irrespective of the presence or absence of the faculty member.
7. Students should not leave the class during class hours or attend it late under the pretext of paying fees, visiting the library etc.
8. Students are expected to read notices/circulars displayed on the College/Institute Notice Board. Ignorance of not reading any notice/circular thus displayed shall not be accepted as an excuse failing to comply with the directions contained in it.
9. All vehicles should be parked in the allotted place. Vehicles found parked in unauthorized places shall be impounded.
10. While attending College/Institute functions, the students will conduct themselves in such a way as to bring credit to themselves and to the institution/College.
11. Spitting, smoking and throwing bits of paper inside the College/Institute campus/Hostels are prohibited.
12. Students are forbidden from entering the College/Institute office and the staff rooms during unspecified hours.
13. Students are prohibited from damaging the building or any other property of the College/Institute/Hostel in any way. The cost of any damage so caused will be recovered from the students collectively if the responsibility for it cannot be fixed on any individual or group of individuals.
14. Representation of complaints and grievances may be made individually to the Principal through the Class Teacher concerned or Discipline-cum-Grievance Committee.
15. No meeting/function of any kind shall be held in the College/Institute premises without the written permission of the Principal.
16. No notice of any kind shall be circulated among students or displayed on black boards or on notice board, no information or report should be sent to press or broadcasting agencies without the permission and approval of the Principal.
17. The Principal will deal strictly with students who play a leading part, by organizing or assisting, in strikes.
18. The students are expected to take up all assignments, tests and examinations of this College/Institute/University seriously and would try to perform the best.
19. Misconduct during examination, production of false information or documents for admission purpose and the failure to return loaned materials or settling debts with the College/Institute would be seriously dealt with.
20. In this campus various courses are conducted simultaneously and hence, students should observe SILENCE in the campus.
21. Ragging and Eve Teasing are considered as crime and strictly prohibited by an act promulgated by the Government with the penalty of Rs.10,000/- and two years' imprisonment. If any student indulges in any form of ragging or Eve-Teasing inside the College/Institute premises or outside, he/she will be summarily expelled from the College/Institute. Students are required to submit Anti Ragging affidavits Annexure III & Annexure IV in prescribed format before the commencement of classes.
22. Each student of this College/Institute must possess Student Identity Card with his/her photograph affixed on it, duly attested by the Principal. The students must compulsorily wear the Student Identity Card inside the College/Institute Campus.
23. Students shall come clean, tidy and modestly dressed in College/Institute Uniform. Students not in College/Institute Uniform would be marked as absent for that particular day. If non-adherence to this rule is reported against a student often, severe action may be initiated against him/her. Students must use aprons while working in lab and hospital.
24. Use of mobile phones within the class is strictly banned. Violation of this rule by any student would result in impounding of the Cell phone and strict disciplinary action against the student.
25. Annual fees are payable in one stroke as prescribed by the College/Institute on or before the scheduled dates to avoid fine. Fine will be charged as applicable for the late fee submission.
26. Fees once paid are not transferable / adjustable or refundable under any circumstances.
27. No student shall be allowed to appear for the university examinations unless he/she paid all his/her dues and completed his/her work assignments to him/her along with minimum 75% attendance in all classes/Lab work.
28. Students staying in hostel are not allowed to use electric / gas stoves, heaters, etc in hostel rooms except in designated places.
29. Loitering in the Hostel campus during the class hours will not be allowed and if found disciplinary action may be initiated.
30. Visitors are allowed only in guest room of the hostel between: 4:30 p.m. and 6:30 p.m for hostellers. Visitors are not allowed beyond the visiting area. No outside Guest/Students will be allowed inside the hostel.
31. Students during their stay in the hostel will be governed by the College/Institute administration rules.
32. In Hostel, Food will be served only in the designated Dining Hall(s) and only during the specified timings. Wasting food & water will not be encouraged.
33. Smoking, Alcohol & Narcotic consumption is strictly prohibited in and around the College/Institute and Hostel premises. Strict action will be taken against offenders by the College/Institute administration or disciplinary committee.
34. Late comers in Hostel will be penalized.
35. Students should not involve themselves either directly or indirectly in any form of politics, Unions or any other such formation either inside or outside the College/Institute during their period of study. If a student fails to comply with this regulation, strict disciplinary action will be initiated against the student as deemed fit by the Disciplinary committee/Principal/Management which may even result in the rustication of the student from the College/Institute.
36. The management reserve the right to change any rules & provisions as and when required.

### FITNESS MEDICAL CERTIFICATE OF THE STUDENT SEEKING ADMISSION IN THE DINESH COLLEGE OF EDUCATION, Farathiya, Garhwa - 822114 (Jharkhand)

#### Medical Examination Criteria :

1. Infectious disease - The student is not suffering from any infectious disease like tuberculosis, Leprosy etc.

16. I will have to vacate the hostel in case of any requirement of the Institution for some specific period for any reasons including accommodating guests, delegates, participants of any event, for maintenance work etc.
17. I shall not collect any money from any student(s), employee(s) or other person(s) for any purpose including donations, Ransom contributions/gathering without the written approval of the Institution.
18. The College has the full authority to call/send for official/academic purposes any time even during holidays or for early or delayed stays even during nights.
19. The College has the full authority for the inspection of the room, bags, almirahs or any of my personal belongings at any time.
20. I understand that hostel, allotted at the time of admission or otherwise, may be shifted to other hostel, at any time and the allotted room, floor and other facilities in the hostel may also be changed at any time, as decided by The College.
21. I shall not allow any unauthorized person to enter or stay/live in my room.
22. I shall not misuse electricity and resources by using electrical gadgets like irons, heaters, audio players, juicers etc. and other electronic/battery/fuel powered (gas/petrol/diesel/kerosene etc.) devices and will not waste food, water and other important resources for fun or owing to casual behavior.
23. I understand that the hostel fee include the electricity charges/amount only for 1 Bulb/LED and a fan and I shall be liable to pay the electricity charges/amount separately in addition to the hostel for use of any extra electrical equipment such as AC, Cooler, Iron, Water heater etc as applicable.
24. If I absent myself from the Institution without permission, I am liable for disciplinary action, which may amount to my rustication/expulsion from the Institution.
25. If declared ineligible for appearing in any examination of the College /University, on account of shortage of attendance or any other reason whatsoever or if ordered by the Institution authorities at any time, I shall vacate the hostel immediately. Readmission to hostel in the forthcoming term/semester may be allowed only at the sole discretion of the College.
26. All type of charges and fee as charged by the Institution are subject to revision from time to time.
27. For any unforeseen issues arising, that is not covered by this Undertaking, or in respect of all the matters, not expressly provided herein, the College may take an appropriate decision that shall be final and binding on me and all other concerned.
28. I am giving this undertaking with full understanding and state that the information given by me above are true and complete to the best of my knowledge and belief and the certificates, documents and other information submitted by me are genuine and nothing has been concealed / suppressed. I understand that if any of the statements made by me above is found incorrect, I shall be liable to such disciplinary action(s) and/ or penalty as may be decided by the College, notwithstanding legal action under the law of the land. In such case, the hostel fee and other charges deposited by me shall be forfeited.
29. The College reserves the right to frame, amend, revoke or repeal the Provisions including hostel timings and that will be effective and binding on all the concerned, as decided by the College from time to time.
30. The Courts in Garhwa, Jharkhand or in case of high court Ranchi, Jharkhand shall have the jurisdiction over all disputes arising out of or in respect of matters relating to students.
